## Regulations/laws

Since 1999, school counselors in South Carolina have been guided by a well-developed program model, written by a statewide counselor committee and endorsed by the State Board of Education. Exciting changes have occurred with the passing of the 2005 Education and Economic Development Act (EEDA) that focuses significant attention as well as increased responsibilities on school counselors. Section 59-59-40 of the EEDA requires school districts to use and follow the state's comprehensive guidance and counseling program in their districts as a model for assistance with the planning, development, implementation, and assessment of their guidance and counseling program.

#### **Education and Economic Development Act (EEDA)**

The Education and Economic Development Act (EEDA), "Personal Pathways to Success" is a program designed to better prepare South Carolina students for the workforce and post-high-school education through early career planning and an individualized curriculum.

## **School Counselor/Career Specialist Services**

Career Specialists provide career awareness, exploration, and guidance services to students in public schools, grades six through twelve.

#### At Risk Student Services

...The EEDA requires that the needs of students "at risk for being poorly prepared for the next level of study or for dropping out of school. (S.C. Code Ann. § 59-59-150)

This K-12 Guidance Plan is designed to be a resource for members of the Colleton County School District educational community. School Counselors will utilize their professional training, leadership, advocacy, teaming and collaboration to ensure that every student in Colleton County School District will have access to a quality and equitable education. This plan is aligned with The South Carolina Comprehensive School Counseling & Career Guidance Model (Pre-K-12).

## **Guidance Curriculum Standards for Student Development**

The purpose of a comprehensive developmental guidance and counseling program in a school setting is to promote and enhance the learning process.

#### SOUTH CAROLINA PROGRAM DOMAINS

The SC Counseling Model provides developmental opportunities and experiences that address three central student-development areas:

- Learn to Live (personal/social);
- Learn to Learn (academic); and
- Learn to Work (career).

It includes sequential activities designed to address the needs of all students by helping them to acquire competence in the knowledge of self and others, in identifying their educational goals, and in their own career development. The program is implemented in each school by the certified school counselor with the support of the career specialists, teachers, administrators, students, and parents/guardians.

#### **LEARNING TO LIVE (Personal/Social Development)**

The development of personal/social standards is an integral part of an individual's pursuit of success in life. To understand and respect self, relate positively to others, make informed and safe decisions, cope effectively with change, and become responsible citizens are essential to this process.

The content standards for personal/social development provide the foundation for personal growth. They enhance the personal, social, educational, and career development of the individual. Students acquire skills to foster relationships with self, others, the family and the community.

## **LEARNING TO LEARN** (Academic Development)

The development of academic and educational standards is an integral part of an individual's pursuit of life-long learning. Being able to achieve educational success, identify and work toward goals, manage information, organize time, and locate resources are essential to this process.

The content standards for academic development guide the student to get the most out of each learning situation. The student experiences success and maximizes educational potential through

effort and commitment to producing high quality work. Academic development includes desired learning goals that require the student to have a command of decision-making, problem-solving, goal-setting, critical thinking, logical reasoning, and interpersonal communication skills.

The development of career standards is an integral part of an individual's pursuit of success in the world of work. Being able to develop the knowledge and skills to make realistic career plans, make a successful transition from school to work, achieve interdependence, and compete in a global economy is essential to this process.

The content standards for career development provide the foundation for the development of skills that assist students in making a successful transition from school to the world of work, and from job-to-job, across the life career span.

Direct Services-Direct services are in-person interactions between school counselors and students and include the following:

Indirect Services for Students-Indirect services, which include referrals for additional assistance, consultation, and collaboration with parents, teachers, other educators and community organizations, are provided on behalf of students as a result of the school counselors' interactions with others.


